Less-Than-Truckload (LTL) Fuel Surcharge

UPS Supply Chain Solutions fuel surcharges are indexed to the *On-Highway Diesel Fuel Prices*, as reported by the U.S. Department of Energy and published on its website each Monday*. Fuel surcharge rates are updated weekly and are applied to shipments originating Tuesday through the following Monday. The LTL fuel surcharge for the week of October 7 – October 14 is 34.50%, based on the published diesel fuel price of \$3.875 per gallon on October 6, 2008.
